Dissolve the current Executive Committee and delegate authority to the Election Commission to conduct the election for a new Executive Committee.

Eligibility and Election Rules (Reference: DUAAA Constitution)

1. Voting and Candidacy

Only *General/Full Members* who have fully paid their membership fees and whose names appear on the official voter list are eligible to:

- Vote in the AGM
- Stand as candidates for election
- Attend the AGM

Associate Members are **not** eligible to vote or nominate for any committee position.

2. Minimum Membership Requirement for EC Positions

To be eligible for election as an Office Bearer or Executive Committee (EC) member, a candidate must have held membership for at least **two years**.

3. Eligibility for President, General Secretary and Treasurer

To be eligible for these positions, candidates must:

- Have at least five consecutive years of General Membership, and
- Have served as an Executive Committee member for at least two years or one full term.

4. Term Limits - President and General Secretary

- A maximum of two consecutive terms may be served in each position.
- The combined service in both positions cannot exceed three terms (six years) in total.

5. Term Limits - All Positions

Office Bearers and EC members may not be re-elected to the **same position** after serving **two consecutive terms (four years)**.

6. Advisory Committee Membership

The outgoing President, Vice President 1, Vice President 2, and General Secretary will automatically become members of the Advisory Committee.

• If any of these individuals contests in the upcoming election for any position, they will lose the right to serve on the Advisory Committee.

7. If nominations exceed the number of available positions, a ballot will be held.

An independent Election Commission has been appointed to oversee and manage the election, with **Abdul Latif Shikder** as Chief Election Commissioner (CEC) and **Tushar Das** and **Mohammed Ibrahim Khalil Masud** as Assistant Election Commissioners (AEC). The Commission will administer the election process in accordance with the relevant provisions of the DUAAA Constitution.

The Election Commission will share voters' contact details with eligible candidates **solely for election purposes**. Members who do not wish their details to be disclosed must notify the Executive Committee **in writing by 1 September 2025**. Failure to respond will be taken as consent to disclose.

Nominations will close at midnight on 30 August 2025. All completed nomination forms (Annex A) must be submitted to the Election Commission via email at shikder@yahoo.com Nomination Submission Fee: \$100 (see form for details).
